Drew will address the elements of direct service connection, secondary service connection, service connection by aggravation, service connection by legal presumption, and obtaining benefits under 38 U.S.C. 1151.

Disability ratings are important because they reflect the severity of the veteran's disability and dictate the amount paid by VA. Christine will cover the various aspects of ratings, including the statutory basis, rating schedule, combined ratings, and diagnostic codes. She will also explain how to assess whether the rating is correct, achieve the proper rating, and consider the effect of the AMA on these issues.

This presentation will cover the basic rules for establishing effective dates for entitlement to service-connected compensation. Jonathan will discuss the effective date rules governing cases decided in the legacy system and under the AMA. He will also review strategies for obtaining earlier effective dates, including a discussion of 38 C.F.R. 3.114, 3.156(b), and 3.156(c).

VA has the advantage in 1151 claims, including control over most records and witnesses, as well as the resources to retain experts who are shielded from cross examination. VA quality assurance records serve to level the playing field as they help undermine VA opinions and close the evidentiary gaps created by one-sided adverse event disclosures. This presentation explains where quality assurance records might exist, strategies for obtaining them, and ideas on how to use them to your advantage in an 1151 claim.

William G. Smith Scholarship

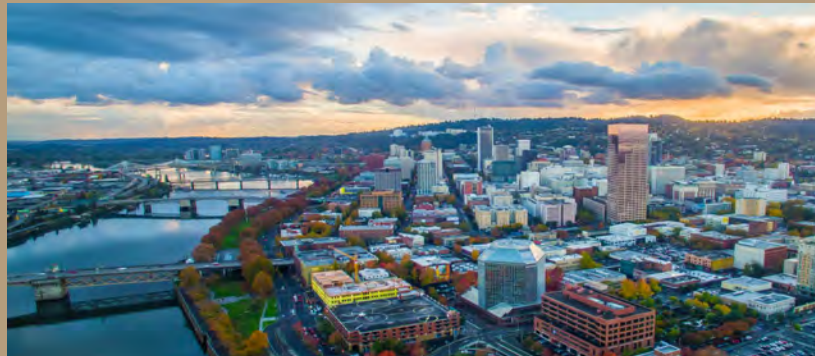
WILLIAM G. SMITH SCHOLARSHIP
